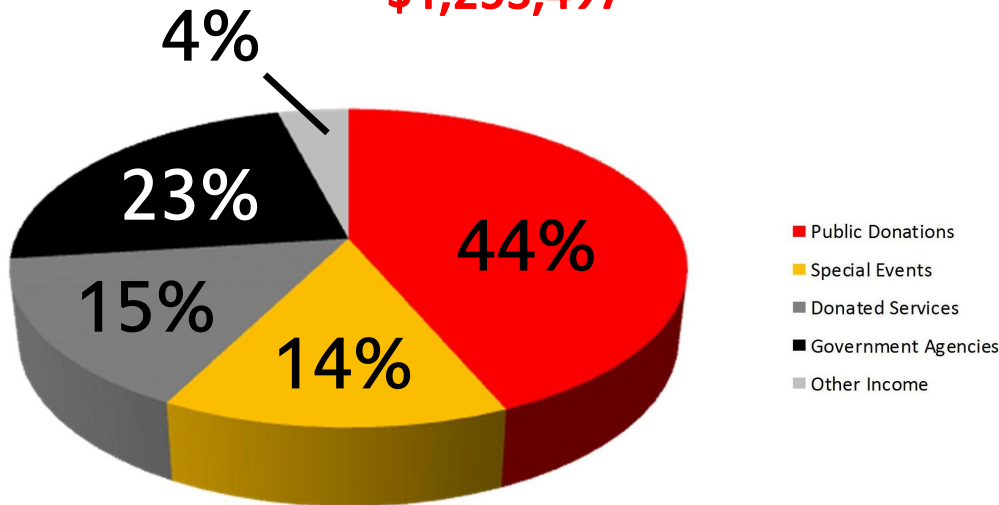


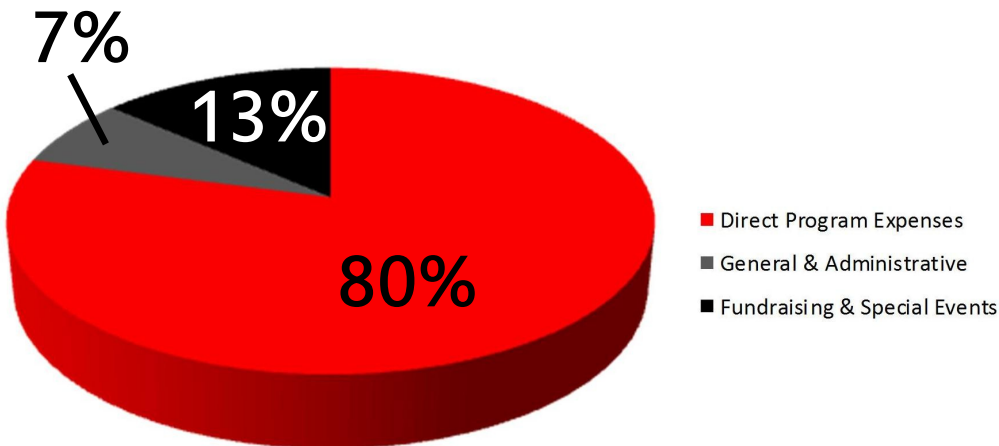
## 2010 Total Revenue & Support
